# Decision of the FIFA Disciplinary Committee

passed on 19 January 2023

## DECISION BY:

**Polly Louise HANDFORD (England), Member**

## ON THE CASE OF:

**Fédération Guinéenne de Football**

(Decision FDD-12460 – former FDD-7532)

## REGARDING:

**FIFA Disciplinary Code, art. 15 (Failure to respect decisions)**

## Decision

- 1. The Fédération Guinéenne de Football is found responsible for failing to comply in full with the award issued by the Court of Arbitration for Sport on 24 March 2022 (Ref. CAS 2021/A/7713).**
- 2. The Fédération Guinéenne de Football is ordered to pay to Mr Paul Put as follows:**
  - **EUR 270,000, plus interest at the rate of 5% *p.a* until full payment as from 16 July 2019.**
  - **CHF 3,000 as a contribution to the claimant's costs in relation to the arbitration proceedings.**
- 3. The Fédération Guinéenne de Football is granted a final deadline of 60 days as from notification of the present decision in which to settle said amounts. Upon expiry of the aforementioned final deadline and in the event of persistent default or failure to comply in full with the decision within the period stipulated, the present matter will, upon request of Mr Paul Put, be resubmitted to the FIFA Disciplinary Committee to impose harsher sanctions on the Fédération Guinéenne de Football, including a possible expulsion from FIFA Competitions.**
- 4. The Fédération Guinéenne de Football is ordered to pay a fine to the amount of CHF 20,000.**
- 5. The fine is to be paid within 30 days of notification of the present decision.**

### **NOTE RELATING TO THE TERMS OF THE DECISION:**
